# What to do and how we can help

#### MAKE COVERAGE AND BENEFICIARY CHANGES

After a divorce, your former spouse or partner isn't eligible to stay on your Walmart benefits. It's easy to take them off your coverage and change your beneficiary to make sure any benefit payments are made according to your wishes. Be sure to make any changes within 60 days of the your divorce.

#### FILE A MEDICAL SUPPORT ORDER

If you need to file a medical support order to make sure your child stays covered, we'll coordinate all court orders from child support agencies. Call Walmart Medical Support Services: <u>877-930-5607</u>.

#### CONTINUE COVERAGE

If divorce means the end of your former spouse or partner's benefits coverage, they can continue medical, dental, and vision coverage temporarily with COBRA. To request COBRA coverage, call People Services within 60 days. Everything else will be handled by WageWorks.
